What is a polygraph?

A polygraph is a diagnostic instrument that records physiological changes in a person whilst undergoing questioning. It relies upon measuring the body's involuntary responses which occur when the subject is consciously being deceptive or truthful.

What can polygraph testing be used for?

Polygraph testing is used to verify, corroborate or disprove statements or allegations. Polygraph technology is also widely used to exonerate those falsely or maliciously accused of professional misconduct, sexual harassment or wrong doing.

Are polygraphs accurate?

Yes. Provided the polygraph examiner is appropriately trained and adheres to high professional standards the reported accuracy is between 90% to 95%. The principles of polygraph testing have been developed over the past 100 years and have been subjected to hundreds of scientifically validated studies. The accuracy rate of polygraphs exceeds various other forms of acceptable forensic evidence.

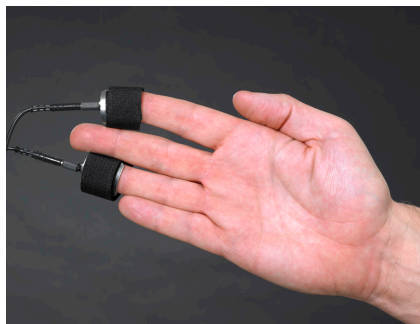
Polygraph testing is used in:

Disputes of fact, fidelity issues, malicious or false allegations, allegations of drug usage, sexual harassment claims, allegations of wrong doing, unfair dismissals, dispute resolution, employee theft/fraud, professional misconduct allegations, investigations, industrial espionage, internal leaks, racing industry, sporting bodies and the media.

Can someone beat the test?

A person doesn't beat a polygraph test they beat the examiner conducting the test. This is why it is imperative to ensure that the examiner you use is certified and qualified. A polygraph is simply an instrument that records changes in autonomic reactivity when a person answers a question. If a person engages in behaviours that are designed to dis-

tort the polygraph tracings then it is the job of a competent and qualified examiner to identify and determine when this is occurring. In most cases it is easy for a qualified examiner to determine when an examinee is attempting to influence the outcome of the exam. Although some parameters can be consciously



controlled these are usually easily detected. Before engaging a polygraph examiner ask them where they trained. Using an unqualified examiner is dangerous and may produce an incorrect result.

Do nerves affect the results of a polygraph test?

No. A polygraph records changes in blood pressure, pulse rate, pulse strength, galvanic skin conductivity and reactivity (sweat gland activity), and changes in pneumographic patterns. It is expected that all people who undergo a polygraph test will be nervous whether they intend to answer questions truthfully or not. An examiner will look for action specific responses over and above the examinee's heightened level of nervousness or anxiety.

Typically an examinee remains nervous throughout the entire testing process not at one individual question. If nerves affected the result of a polygraph test then no one would ever pass a test.

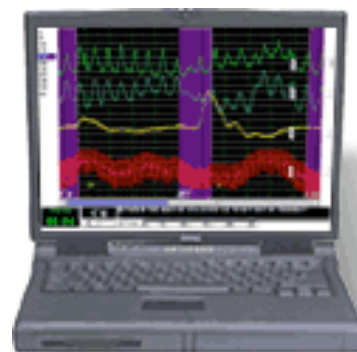

Howard in relation to the “Children overboard” scandal

- The Polygraph test of Andrew Mallard in relation to his suspected involvement in the murder of Pamela Lawrence in West Australia in 1994. Mallard requested and underwent a polygraph test whilst in custody and was eventually released after nearly 12 years in prison,

- A polygraph test conducted on the leader of the Democrats Senator Andrew Bartlett

- The behavioural analysis of interviews conducted by Liz Hayes of 60 Minutes with Schapelle Corby the Australian woman charged with importing 4.1 kilograms of cannabis into Indonesia inside a body board bag

- The analysis of an interview conducted by Tara Brown of 60 Minutes with former Guantanamo Bay detainee Mamdouh Habib denying his involvement in terrorism or links with al-Qaeda

- Polygraph testing for over 40 high profile homicide cases for various police departments.

Are polygraph results admissible in (Australian) courts?

No. Generally it is the role of the courts and juries to determine guilt or innocence not a polygraph examination result. Polygraph tests are not intended to be a means for delivering a legal verdict, but rather an invaluable investigative tool.

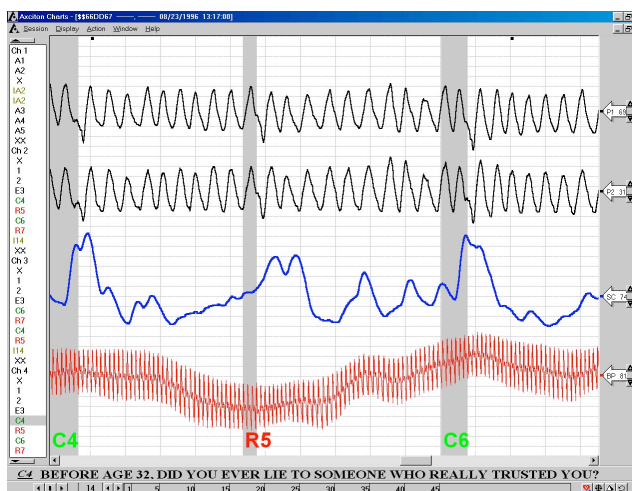
